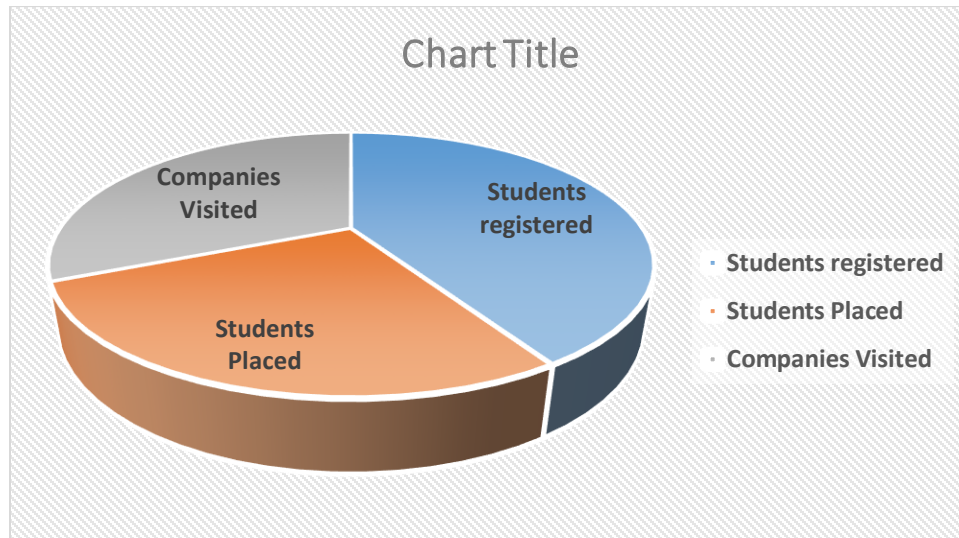

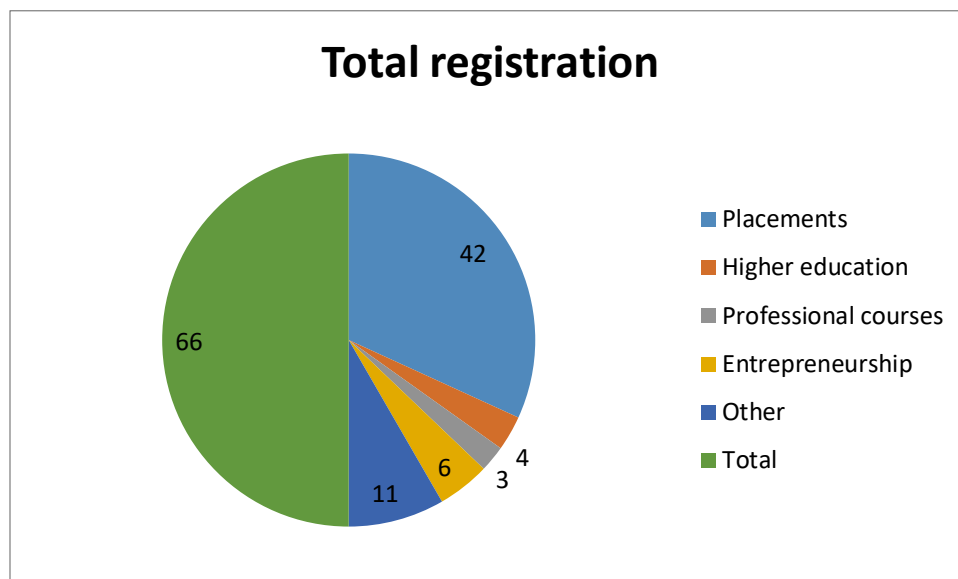

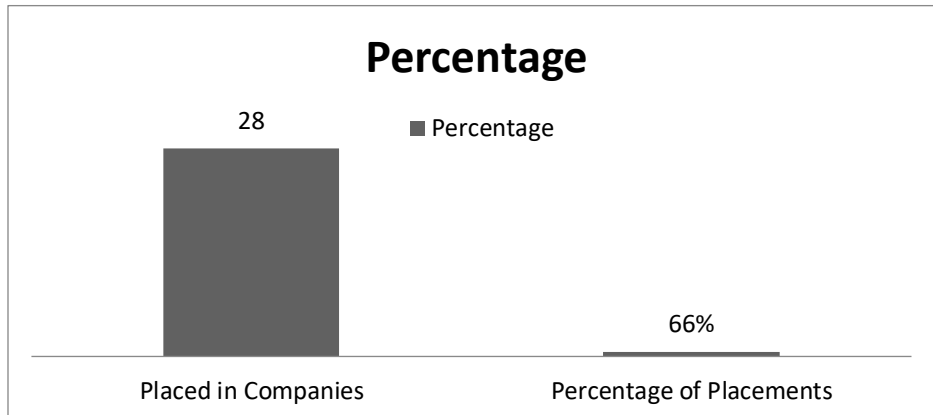
Students Placed & Percentage of Placements.
